#### **General Information:**

This is an Agility Association of Canada (AAC) sanctioned trial that will be held under AAC rules and regulations. Note that the Dogs All Day Trials Organizing Committee reserves the right to refuse any entry. All entries are to be submitted via the indicated Forms URL.

#### **Refunds and Credits:**

Refunds will be issued for withdrawn entries received before the closing date (see first page of this premium). There shall be no refunds for acts of God, inclement weather, missed runs, entries withdrawn after the closing date, dogs and/or handlers dismissed from the competition, regardless of the reason for such dismissal, or absence on the day of the trial. Refunds may be requested for injured dogs or bitches in season, however, all such refunds will be subject to a \$15 administration fee, and Dogs All Day reserves the right to require a veterinarian's note.

#### Run Order and Trial Schedule:

Please check and forward any necessary changes to the Trial Secretary prior to the trial – including issues with the run order, as this order will not be changed after the start of the trial – this will help the trial to run smoothly. Although a provisional time schedule will be provided to competitors prior to the trial, be aware that events may begin up to 30 minutes prior to their scheduled start at the discretion of Dogs All Day. No event will start more than 30 minutes prior to the scheduled time unless all competitors are present.

#### **Trial Obstacles:**

All obstacles conform to AAC specifications and include Galican Dog walk, Galican Seesaw (teeter), Galican A-frame, Weave Poles, Flexible Tunnels, 24" Galican soft tire Jump, Ascending Spread Jump, Double Jump, Triple Jump, Galican soft Broad Jump, and Winged Jumps. All contacts are rubberized. The trial will be held outdoors on a grass surface and a bathroom is available inside the facility. Competitors are responsible for providing their own seating, drinking water and dog crates.

#### **Trial categories:**

Dogs will be divided into 6 height groups into 4 categories (Regular, Special, Veteran and Double Drop Veteran). Masters Standard is open to dogs that have an AADC title. Advanced Standard is open to dogs that have an ADC title, Starters Standard is open to dogs that do not have an ADC title (3 qualifying scores in 2 different judges).

## Move-ups, FEOs, Senior/Disabled/Junior Handlers:

Move-ups will be allowed during the trial, provided space and time allow. FEO runs are to be indicated in the entry form. Senior/Disabled status and/or Junior Handler status is to be indicated in the entry form.

#### Course Maps:

Course maps will be emailed to each participant on the day of the trial 2hrs before the start of the first event

## Titles:

Please advise the Scorekeeper if your dog completes a title:

- -Qualifying ribbons for all event qualifiers.
- -Placement Ribbons awarded for 1st through 4th place.
- -Title Rosettes for any dog completing an AAC title.

#### Bitches in Season:

At this time, bitches in season are not allowed to compete at this trial. Please let the trial secretary know as soon as possible if your bitch falls into season and you are no longer able to attend the trial. A refund will be issued

## **Trial Volunteering:**

These trials cannot be held without your assistance and we hope that all competitors will help to the best of their abilities around their entries. When registering you will have the option to opt in or out of volunteering. Competitors will be emailed a volunteer schedule before the trial. Please check this schedule and communicate any conflicts or other difficulties as soon as possible.

## **Ring Etiquette:**

Competitors not entered in a specific event are NOT permitted in the ring during the walk-through. If you are entered in an event and you are coaching others (or being coached by others), please show consideration for the rest of the competitors by doing your coaching outside the ring and do not block other competitors, or hold strategy discussions in the ring during the walkthrough. Food is not permitted in the ring at any time. Non-audible toys in good condition are allowed in the ring only during FEO runs and may be thrown up to ten feet. Dogs must enter and exit the ring on a leash - the leash may be dropped at the start line, or carried in the handler's pocket.

#### **Dog Control and Aggression Issues:**

All dogs must be kept in an X-pen, crate, in your car, or on a leash when not in the ring (this includes the grounds and the parking lot). To prevent incidents of dog aggression towards other dogs and/or people, please give all dogs lots of room and be aware of your dog's behaviour at all times. Any dog engaging in aggressive behaviour at any time may be required to leave the grounds at the sole discretion of the trial host and/or judge. In such cases, NO refunds will be issued.

## **AAC Participant Waiver & Release:**

In consideration of the acceptance of this entry by AAC and Dogs All Day (the "Organizing Club") and the opportunity to have the dog participate, compete in and/or be judged at this event or trial (the "Event"), I, the undersigned, agree as follows: I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner of the dog and that the dog is not a hazard to persons, property or other dogs. I agree that AAC or the Organizing Club for the Event may refuse my entry for any reason that it deems to be sufficient. understand and acknowledge that participation in the Event carries certain risks, including, but not limited to injuries (including serious injuries and death) to myself, the dog, any other guests (my "Related Parties"), damage to property and other losses. I waive any and all claims that I have or may have in the future against, and release from all liability and agree not to use AAC, the Organizing Club or any of the directors, executives, committees, representatives, employees, volunteers or agents of either AAC or the OrganizingClub (the "Personnel") for any injury, death, property damage or other loss that I or my Related Parties sustain due to any cause whatsoever, including negligence, breach of contract, breach of duty, statutory or otherwise, or mistakes or errors of judgment of any kind. I assume full responsibility for the conduct of myself and my Related Parties during the entirety of the Event.
