## General Information

- Check in and Start Times for each component/game will be determined once the trial is full.
- Entry limits A handler may enter only one dog in a given component per level per day.
- Your dog must have passed the prior level for a component to register for the next level.
- No onsite registrations will be accepted. Open to all breeds & mixes.
- RP will be processed before Non RP entries for the first 72hrs after the opening date
- Entries received before the opening date & time will NOT be processed
- Entries exceeding trial limits will be placed on a waitlist.
- Please advise 48 hours prior to trial if bringing a bitch in season.
- Payment MUST be received within 48 hrs after confirmation you are in the trial.
- If the trial fills a waitlist will be created. If a space becomes available it will be offered to waitlist members in the order in which their registration was received.
- Confirmations: Entry confirmations will be emailed, allowing 2-3 days for processing. Do not send payment until you receive confirmation.
- COMPETITORS Submission of your entry acknowledges that you have reviewed the RULES and REGULATIONS in the Master Rule Book on the SDDA site. [www.sdda.ca](http://www.sdda.ca)
- Running order will be posted and emailed prior to the event and will be posted day of
- Refunds Up to the closing date refunds will be issued for any reason as long as the spot can be filled from the waitlist. After the closing date, dogs may be withdrawn due to illness, but refund will only happen if the spot can be filled from the waitlist and a veterinarian note is provided. Handlers needing to withdraw due to illness will be refunded as long as the spot can be filled from the waitlist. No refund 3 days before trial is to commence. There will be a \$5 per transaction processing fee for all refunds.
- Awards Qualifying ribbons will be presented per component and rosettes for titles/placements.
- Refreshments There will be no snacks to share please bring your own lunch
- Dogs Dogs must be under control at all times. Do not allow your dog(s) to pee on anything man made.
- Pick up after your dog(s) immediately. Dogs must be on leash when not crated or in the search areas. Do not allow your dog to approach other dogs or people without explicit permission.
- There will be no indoor crating available at this event
